CONDITIONS OF ENTRY

1. Entries must be presented in a clean, complete and safe working condition.
2. All entries must be insured against third party risks, fully licensed and tested in accordance with the regulations applicable to that type of vehicle for road use. The organisers reserve the right to ask for proof of these items.
3. **VEHICLES MUST ARRIVE NO LATER THAN 0930** for the vehicle to be parked in the shed. Vehicles arriving between 0930 and 1000 will be parked in the yard. Vehicles arriving after 1000 may not be able to park in the yard.
4. It is the owner's responsibility to ensure that all drivers are fully qualified in law to handle the class of vehicle exhibited.
5. No exhibit shall be left running unattended. All unattended vehicles must be left securely braked or chocked.
6. Entrants and crew must pay full regard to the stewards' instructions and conduct themselves in a manner, which will not inconvenience other road users or exhibitors.
7. Vehicles must not be moved once parked on display except under instructions from stewards.
8. Vehicles running on service must be in suitable condition and insured for carrying passengers.
9. **Because of the nature of our site and in compliance with Health and Safety Regulations, any exhibited vehicle must remain on site until 17.00.**
